CITY COUNCIL MINUTES

April 28, 2014

- 1. Regular meeting called to order at 7:00 PM by Mayor Campbell in Council Chambers at City Hall.
- 2. Present at roll call were members: Jarvis, Jasperse, Klein, McNabb-Stange, Redman, Tossava, and Wood.

Motion by Tossava, with support by McNabb-Stange, to excuse Member Bowers. All ayes. Motion carried.

City Staff and Appointees present: Mansfield, Emery, Caris, Hart, Girrbach, Holzwarth, Pratt, and Fekkes.

- 4. Approval of the agenda.

Motion by Tossava, with support by Wood, to add Items 14.J., MDOT schedule for South M-37, 15.E., to set a budget workshop for May 12, 2014, and 15.F., to set a public hearing for the parking Special Assessment District, and to approve the agenda as amended. All ayes. Motion carried.

5. Approval of the minutes of the regular meeting of April 14, 2014.

Mayor's Springtime of Thanks Program: Mayor Campbell presented a proclamation recognizing and thanking the Thornapple Arts Council for their contributions to the quality of life in the Hastings Community.

Megan Lavell appreciated the recognition. She announced record attendance at Jazz Festival and thanked City staff for cooperation.

 - A. Jerry Sarver made comments on retiring as Chief of Police. He stated that cutting police staff resulted in mandatory overtime and that single officer shifts increase the risk to the officer and the public. He stated that a union grievance and unfair labor practice charge should not have created a delay in filling a vacant patrol

officer position. He claimed that the City Manager is equivocal about filling the Deputy Chief position and insisted that having an immediately available second in command is imperative. He recommended that Council be aware of and safeguard effects of stress load on City Manager. Finally, he complained about the allocation of Administrative Services cost of about \$500,000.00 to the police department. He suggested that no expense should be charged to a department unless the department head had control over disbursements.

- B. Tom DeVault, Executive Director of the YMCA presented update of programs. He stated that spring baseball registration has decreased but that the Y is expanding swimming lessons, golf and tennis, and instituting new programs including "Gaga Ball", Middle School babysitting certification, Play 60, Lego Robotics, and 5K Running.
- C. Consider request from David N. Stevens, National & Regional Director Pierce Arrow Society, for reserved parking spaces for an event.
